## Mass Meeting of the

Lee County Republican Committee of the Republican Party of Virginia

As Chairman of the Lee County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Travis C. Mullins, do hereby issue this call for a Mass Meeting to be held at the Lee High School Auditorium (Gymnasium as an alternate location), 200 Generals Lane, Jonesville, Virginia, starting at 11:00a.m. (Registration begins at 9:00a.m.) on Saturday, April 27, 2019 for the following purposes:

### **Qualifications for Participation**

All legal and qualified voters of Lee County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Participants are asked to bring their voter registration card, or if not available another form of identification to be used for meeting registration purposes.

#### Filing Requirements

Individuals seeking the Republican nomination for the above named offices shall be required to pre-file their intention of seeking such nomination. A written candidate form can be downloaded from the Republican Party of Lee County website at <a href="www.leevagop.com">www.leevagop.com</a> or picked up at the Headquarters Office. This form is required to be filed no later than 6:30p.m. on March 21, 2019 by mail at P.O. Box 101, Jonesville, Virginia, 24263 or in person to the Lee County Republican Headquarters. Postmarks will not be considered. Only those whom have pre-filed will be considered for nomination at the Mass Meeting unless approved from the floor by 2/3 vote.

# Registration & Filing Fees

There will be no registration fee to participate in this mass meeting. There is a \$50 filing fee for candidates seeking a county nomination, or \$25 filing fee for candidates seeking a Board of Supervisor's nomination. This payment must be submitted with the candidate form prior to the above mentioned deadline.
